Selectmen Meeting 10/25/2022
Approved Minutes

Called to Order: The meeting was called to order at 7:34pm by Chair Kate Batcheller, attendance was taken by roll call as reflected above.

Approvals:

- Noted that the accounts payable and payroll manifests had been reviewed and approved prior to the meeting.

New Business:

- Conservation Commission members Bob Larochelle & Liz Fletcher attended to get an update on potential junk vehicles located on L-45. Selectmen John updated that he performed a site walk. No buried vehicles, dangerous leaks from vehicles or smashed vehicles were noted at the time of the site walk.
- Moderator Dotsie Millbrandt discussed room set up for the upcoming elections.
- Greenville resident Mike Sadowski came to express concern regarding the noise level from the Driving Range concert on 9/30/22. Mike explained he lives about 1.25 miles away from the Driving Range and was able to clearly hear the lyrics and music of the 9/30/22 Driving Range concert from his front porch (cell phone recording provided). He did go to the Driving Range and complained to Nicole Ruggiero and Chief Maxwell, who were both in attendance, on the evening of the concert. After speaking to Chief Maxwell, a call was made by Mike's wife to the Mason Police Department. Mike also notes he did not have any complaints during the 10/1/22 Driving Range concert. Selectmen discussed this has been an ongoing discussion and briefly reviewed the steps they have been taking

over the last several months to ensure the Driving Range is in compliance with the approved noise level during concerts.

- Kate asked Jen to reach out to the Recreation Committee to find out what type of holiday celebrations are being planned for December 2022.
- Setting the 2023 tax rate was discussed.

Public Comment:

- A tenant who received an eviction notice due to a property being deeded to the Town requests the Selectmen grant more time before needing to vacate her current residence. Selectmen were unable to grant request.
