No Update

Foundation Work

Wally Brown and Mark and Matt LeClair are waiting until the ground is dry late spring of 2023 to reset 5 of the piers supporting the building foundation with cement blocks set in the ground. They will be replacing the damaged supports and whatever else is necessary to confirm that the foundation is properly supported. This course of action will sufficiently support the building at considerably less cost and expense than the original plan of pouring concrete footings and pads. It will be 2 or 3 days of work to complete.

Windows Project

This project is on hold pending the roof renovation based on Marty Milkovits' recommendation that the roof be a higher priority.

Roof Project

The committee discussed and agreed on the priority. The issue is solving the financing since the roof will be costly and we do not have the funds to take it on or even to come up with 50% to

match a grant application with LCHIP. Jim went through the files to gather the requirements and costs associated with the roof and sent the Committee, the James Garvin inspection report, an excerpt from the Assessment Report containing the assessment of the roof as well as an excerpt of the projected costs to repair, and copies of some of the correspondence regarding construction of the roof.

Discussion was tabled since Marty was unable to attend the meeting. Jim left Ken Rafter a hard copy set of the documents to discuss with Marty before the next meeting or at the meeting if they could not speak before then.
