Hazard Mitigation Plan Update

The Planning Board in partnership with Nashua Regional Planning Commission (NRPC) is facilitating the update to the Town of Mason Hazard Mitigation Plan adopted July 26, 2011. Funding for NRPC to manage the plan update is provided through Homeland Security & Emergency Management (HSEM FEMA Pre-Disaster Mitigation Grant (PDM). Inputs to the update are expected to be completed over a series of three meetings.

Cassie Mullen of NRPC, detailed the process for gathering and incorporating updates that will ultimately lead to a public hearing by the Board of Selectmen prior to adoption of the updated plan.
