# **New/Continuing Hearings**

### MAS 20-03: Dr. Roberto Pineda and Shirley Chodin

A voluntary lot merger to combine lot F-11-5 on Old County Road with lot F-10 on Starch Mill Road. Dr. Pineda is the owner of both plots. Shirley Chodin has power of attorney (her name is pronounced hoo-deen). The power of attorney should be filed with the voluntary lot merger.

### MAS 20-02: Brendan Kilcoyne and Timothy O'Toole

Application to subdivide lot H-5 (203.75 acres) with frontage on Brookline Road. The result with be four lots, lot H-5 (50.29 acres), lot H-5-1 (50.74 acres), lot H-5-2 (50.52 acres), and lot 50-5-3 (50.43 acres). All lots will be serviced by a new road, underground utilities, onsite septic, and individual wells. Lot H-5 is located in the GRAF district and lies outside of the 100-year floodplain.

There is an additional conservation easement to protect the area where the conservation commission found some unusual plants. This easement is in H-5-1.

CC report is very positive about the conservation measures planned by the applicants. CC found sundew plants, cardinal flowers, turtlehead flowers. CC suggests widening stone area around culvert. Applicants have updated their plans to include these suggestions.

Driveway easement has been updatet to reflect Atty. Drescher's review comments.

Randy went through the 17 road review comments submitted by town engineer Michael Vignale. The revised drawings will go back to him for confirmation.

The applicant would like to begin clearing trees for the road before winter sets in. The board thinks the road plan, while not complete, is sufficient to allow this to proceed. Dane made a motion saying the board is okay with this. Scott seconded. Vote: Scott - aye, Dane - aye, Dotsie - aye, Kate - aye, Charlie - aye.

Scott made a motion to continue hearing MAS 20-02 to October 28 at 7:10 in the Town Hall. Dotsie seconded. Vote: Scott - aye, Dane - aye, Dotsie - aye, Kate - aye, Charlie - aye.

### Other Business

Selectmen want us to cut our budget by 3% from last year. Scott suggests reducing our training budget and our supplies budget. NHMA is having a fall conference, but the flyer contained nothing about its contents.

### **Action Items**

Keeping a running checklist of changes the board should make to the subdivision regulations and application checklist at some future time:

- Hillsborough Country Conservation Service no longer certifies soils on survey plats
- Update Payments chart
- Cul-de-sac instead of hammerhead turnaround
