**Selectmen's Meeting**

**Appointments:**

1. Town Clerk/Tax Collector Susan Wagoner presented the civil forfeiture list of dog owners to Police Chief Hutchins. The P.D. will be serving the forfeitures on the owners in the next few weeks. Mrs. Wagoner based some of the forfeitures on the information listed by property owners on the Inventory form. Some owners listed dogs that had never been licensed by the Town.  
Mrs. Wagoner told the Board that the first billing for the semi-annual taxes has been successful as tax payments are steadily coming into the office. Because of the tax revenue, the Town may be able to stop drawing from the TAN.
2. Police Chief Hutchins updated the Board on two major cases that the PD is working on:
  - Child pornography issue- this has been occupying at least 30 hours per week of Officer Duval's time. The case will be prosecuted federally.
  - Violent rape case – this case involves a Vermont residence. Normally the case would be handled by other agencies but because the county is limited on its resources, the Mason PD, with assistance from the State Police, is the lead agency on this case. The County Attorney's office will be prosecuting this case.

**Selectmen reviewed the following:**

1. From Wilton Recycling Committee: Contract for Recycling Services  
Budget for Wilton Recycling Center and Recycling Subcommittee's report were reviewed. Selectman Anne Richards as the new ex-officio on the Committee attended the last meeting and gave a synopsis of the meeting. The Center seems to be financially stable due to the increase in recycling. The Subcommittee will be distributing a survey to further increase resident's interest in recycling. After some discussion, Chairman Richardson signed the new contract.
2. Temporary Completion Certificate: Cunningham, lot D-11-9, 260 Gilman Hill Road for six months to live in their mobile home until completion of their new home.
3. Completion Certificate: Farrell, lot F-39, 623 Brookline Road – new house.
4. House Number: Lot B-2-4 – 176 Abbott Hill Road. Selectmen discussed the importance of residents displaying their house numbers correctly. This matter will be given to the new Selectman Robert P. McGinnity to resolve.
5. Re: Elderly Exemption – Robinson – paperwork for 2010 was reviewed and approved for 2010.
