- 1. Moderator Catherine Schwenk discussed the upcoming Special Meeting. She had 3 questions for the Board:
 - Can the article be amended? The feeling is that it cannot because it is based on an RSA.
 - How long do the polls need to be open? The RSAs are explicit about polls open one hour for voting for bond issues but this voting time may be at the Moderator's discretion.

• Who sets the Road Agent's salary? This is set through the budget process. Mrs. Schwenk will contact the Attorney General's Office and the Secretary of State's Office for an opinion on these questions. The Selectmen will also contact Town Counsel for his opinion. It was decided that Selectman McGinnity will introduce the warrant on Saturday.

- 11. Email from CC Chairman Robert Larochelle concerning update on RR Trestle on Jackson Road. Mr. Larochelle met with town engineer Dennis LaBombard who reviewed the plan for the concrete replacement. Mr. LaBombard had a concern for the support post pockets, to be addressed immediately. He also advised that protecting the I beams is critical to the bridge longevity. At this time, no firm decisions on the trestle replacement have been made by the ConCom.
