### **New Business:**

- Governor's Office for Emergency Relief and Recovery Locality Equipment Purchase Program – Tony Burns would like to apply for this grant and if approved, use the funds from this program to purchase a command vehicle for the Fire Department. This vehicle would be used on calls, for medical services and to transport biohazardous material. There is a 5% match in funds from the town. Selectmen ok'd
- Conservation Commission has looked into using "beaver deceivers" for the culvert on Scripps Lane. They would need to first clear out the culvert for a proper assessment/estimate. They are requesting the highway department to assist with this clearing out. Selectmen asked for Conservation Commission to reach out to road

Agent Dave Morrison to get a better understanding if the highway equipment can safely be used on Scripps Lane for this. Dave to call Pete with plan of action before moving forward with clearing out the culvert.

- It was discussed that new members will be joining the Recreation Committee.
- Jen to respond to public inquiry regarding hunting on posted land.

**Old Business:**

- Jen to distribute New Personnel Manual this month with an effective date of December 1<sup>st</sup>, 2021.

**Public Forum:**

- Bob Dillberger would like to update tax maps. Jen will forward Bob log in information for current registry of deeds software.
